

## **PRIVACY POLICY**

### **1 Introduction**

1.1 Greener Power Scotland Ltd are committed to safeguarding the privacy of persons for whom we process personal data. In this policy we explain how we will treat personal data processed by us, in accordance with data protection legislation, and with the General Data Protection Regulation ('GDPR').

1.2 Personal data includes any information relating to an identified or identifiable natural person ('data subject') who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

1.3 Processing, for the purpose of this Privacy Notice, means any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaption or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction.

1.5 By consenting to this Privacy Notice you are giving us permission to process your personal data specifically for the purposes identified within this Privacy Notice.

1.6 You have a right to withdraw your consent to our processing your Personal Data at any time, and we have outlined the process for such a withdrawal within this Privacy Notice.

### **2 Processing Personal Data**

2.1 We will only process such Personal Data which is adequate, relevant and limited to what is necessary to enable Greener Power Scotland to provide our cost comparison service.

2.2 We may process the following kinds of personal data from your visit to our website:

- information about your visits to and use of this website (including your IP address, geographical location, referral source, length of visit, page views.
- information that you provide to us enables us to provide our service to you, (including your name and email address) (you can inform us at any time you no longer wish for us to provide our service and that we remove any information we hold from our records.
- information that you provide to us when using the services on our website, or that is generated in the course of the use of those services.
- information contained in or relating to any communication that you send to us or send through our website (including the communication content and metadata associated with the communication);
- information required so as to deal with enquiries and complaints made by or about you relating to our service;
- information required so as to keep our website secure and prevent fraud;
- information required so as to verify compliance with the terms and conditions governing the use of our website (including monitoring private messages sent through our 'Contact Us' page on our website; and
- any other personal information that you choose to send to us.

2.3 In the event that we need to obtain Special Personal Data from you, we will always tell you why, and how the information will be used.

2.4 We will process Personal Data for the following lawful purposes:

- Legitimate interests of our organisation. These include, the administration of our business, on behalf of our suppliers, processing contracts.
- Performance of a contract or to enter pre-contractual negotiations;
- Compliance with a legal obligation placed on us;
- To protect the vital interests of either yourself or another person.
- For other reasons with your consent, which can be withdrawn at any time.

### **3 Disclosing Personal Data**

3.1 We may disclose your personal data to any of our employees, officers, professional advisers, agents, suppliers insofar as reasonably necessary for the purposes set out in this policy.

3.2 We may disclose your personal data obtained from you by our agents, insofar as reasonably necessary for the purposes set out in this policy.

3.3 We will not, without your express consent, supply your personal data to any third party for the purpose of their or any other third party's marketing.

3.4 Any third party who we share your personal data with are obliged to keep your details securely and when no longer needed, to dispose of them in accordance with our approved procedures.

3.5 We may disclose your personal data:

- to the extent that we are required to do so by law;
- in connection with any ongoing or prospective legal proceedings;
- in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk);

### **4 Retaining Personal Data**

4.1 Personal data that we process for any purpose or purposes shall not be kept for longer than is necessary for that purpose or those purposes.

4.2 Unless we advise you otherwise, we will retain your personal data for as long as we need to in order to provide our services. We determine retention periods for personal data based on legal requirements and best practice.

### **5 Security of Personal Information**

5.1 We will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information.

5.2 We will store all the personal information you provide on our secure password- and firewall-protected cloud network.

5.3 You acknowledge that the transmission of information over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.

## **6 Amendments**

6.1 We may update this policy from time to time by publishing a new version on our website.

6.2 You should check this page occasionally to ensure you are in agreement with any changes to this policy.

## **7 Your Rights**

7.1 You have the following rights regarding the personal data which we hold about you:

- right of access – you have the right to request a copy of the information that we hold about you;
- right of rectification – you have a right to correct personal data that we hold about you that you think is inaccurate or incomplete;
- right to be forgotten – you can ask for the personal data which we hold about you to be erased from our records;
- right to restriction of processing – you have a right to restrict the processing of personal data;

## **8 Complaints Procedure and Right to Legal Redress**

8.1 In the event that we refuse your request under rights of access, we will provide you with a reason why.

8.2 If you wish to make a complaint about how your personal data is being processed by us, or any third party on our behalf, we would be grateful if you would in the first instance contact our Data Protection Officer, Tony Gibson, who will endeavour to resolve your issue to your satisfaction.

8.3 In the event that your complaint cannot be resolved, you have the right to complain directly to the Information Commissioner's Office and seek other legal remedies.

## **9 Third Party Websites**

9.1 Our website may include hyperlinks to, and details of, third party websites.

9.2 We have no control over, and are not responsible for, the privacy policies and practices of third parties.

## **10 Updating Personal Data**

10.1 You are responsible for letting us know if the Personal Data that we hold about you needs to be corrected or updated.

## **11 Transfers of Personal Data to Third Countries**

11.1 If we need to transfer Personal Data for processing to a Third Country (which is to say a country outside of the EU), we will only do so, where we have either

- we have obtained your specific consent to the proposed transfer, and you have been advised of the possible risks of such transfers;
- the transfer is necessary for the conclusion or performance of a contract concluded in the interest of you, and us, and another party;
- the transfer is necessary for the establishment, exercise or defence of legal claims; and / or;
- the transfer is necessary in order to protect the vital interests of you or others, where you are physically or legally incapable of giving legal consent.

## **12 Cookies**

12.1 Our website uses cookies.

12.2 A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server.

12.3 Cookies may be either "persistent" cookies or "session" cookies: a persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted by the user before the expiry date; a session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.

12.4 Cookies do not typically contain any information that personally identifies a user, but personal information that we store about you may be linked to the information stored in and obtained from cookies.

12.5 We use session and persistent cookies on our website.

12.6 Most browsers allow you to refuse to accept cookies.

12.7 Blocking all cookies will have a negative impact upon the usability of many websites.

12.8 If you block cookies, you may not be able to use all the features on our website.

12.9 You can delete cookies already stored on your computer.
